### 1. Description:

The Written Procedure in accordance with article 4, paragraph (2)d and article 7 of the Rules of Procedure of the JMC of the Interreg - IPA CBC Bulgaria – Turkey Programme 2014 - 2020 for approval of change in the partnership of project "Joint Network for Common Traditions and Customs in Transborder Area" with reference number CB005.1.23.033 was initiated by the Managing Authority – Ministry of Regional Development and Public Works, Bulgaria on 04.09.2017.

JMC approves replacement of "Merich District Kadıdondurma Village", Republic of Turkey with "Municipality of Merich", Republic of Turkey as project partner 2 in project "Joint Network for Common Traditions and Customs in Transborder Area" with reference number CB005.1.23.033.
