Written procedure No.27, initiated on 17 May 2019

1. Description:

The Written Procedure in accordance with Article 7 of the Rules of Procedure of the JMC of the Interreg-IPA CBC Bulgaria – Turkey Programme for approval of the Pre-contracting report from the performed on the spot visits to the projects with works component and conducted budget optimization and projects' content modification of the projects provisionally selected for financing and included in the reserve list under the Second Call for Proposals, was initiated by the Managing Authority – Ministry of Regional Development and Public Works, Bulgaria on 17 May 2019.

The official letter No. 99-00-2-264/17.05.2019 with the proposed Pre-contracting report under the Second Call for Proposals, letter and statement concerning project proposal CB005.2.12.072 were sent to the JMC members via e-mail and made available in the JMC section of the Management Information System.

The JMC members were given 10 working days to send their approval or comments on the proposed documents.

Comments and approvals of the Pre-contracting report under the Second Call for proposals were received from Ministry of Foreign Affairs, Republic of Bulgaria, Greener Bourgas Foundation and Ministry of Foreign Affairs, Republic of Turkey and are reflected in Attachment 1: "Table of the comments received from JMC members".

2. Decision:

1. JMC approves the results of the pre-contracting procedures with the preliminary approved for funding projects and the reserve projects as described in the Pre-contracting report;

2. JMC gives mandate to the Managing Authority to sign subsidy contracts with the approved for funding projects as described in the Pre-contracting report;

3. JMC agrees the decision regarding funding of the reserve projects to be taken on the basis of financial analysis and proposal

for the use of the remaining available funds with a view to the achievement of the Output indicators and the full absorption of funds under the Programme that shall be elaborated by the Managing Authority and the National Authority.


The hereby decisions enter into force on the 11 June 2019, the date following the deadline for submission of comments/ objections/ additional proposals from the JMC members.


