**1. Description:**

The Written Procedure in accordance with article 7 of the Rules of Procedure of the Monitoring Committee (MC) of the (INTERREG VI-A) IPA Bulgaria Türkiye Programme 2021-2027, for consideration and approval of the proposal for revision of the Guidelines for Pre-Defined Applicant of the Restricted Call for Strategic Project Proposal under Priority 3 – Specific objective "Mobility and migration management" (1<sup>st</sup> call for proposal).

The official letter No. 99-00-2-61/08.03.2023 was sent to the MC members via e-mail on 08.03.2023.

Bearing in mind the specificity of the project and the responsibilities of the project partners related to the security of the border area, the Managing Authority considers that the inclusion of the opportunity project partners to use real costs for event organisation and to present market research instead of 3 official offers in case of very specific equipment will facilitate preparation and implementation of the activities under the project. The respective texts are included in the Guidelines for Pre-defined Applicant (eligibility of expenditures and supporting documents parts).

Given the above and in order for the project partners to conduct the necessary market research for the supply of specific equipment, the Managing authority proposes to extend the deadline for submission of the project proposal until 23<sup>rd</sup> of March 2023.

The MC members were given 2 (two) working days to send their approval or comments of the proposal.
