


# CHIEF DIRECTORATE FIRE SAFETY AND CIVIL PROTECTION - MoI

Chief Directorate "Fire Safety and Civil Protection" is a national specialized structure of the Interior Ministry to ensure fire safety, rescue and disaster protection under the terms and conditions of the Ministry of Interior Law and the Law on Disaster Protection.

#### TASKS of RD FSCP

- 1. Fire & rescue activities;
- 2. State fire control;
- 3. Preventive action;
- 4. Authorization and control activities of traders that carry out fire safety facilities and/or operation of equipment and Facilities related to fire safety;
- 5. Authorization and control activity of the products in terms of fire extinguishing their efficiency;

### TASKS of ChD FSCP - Mol

- 6. emergency repair work, operational flood protection operations and search and rescue, CBRN protection;
- early warning and alert disaster and aerial threat of the executive authorities and the population;
- 8. methodological and expert assistance in disaster protection of the territorial bodies of the executive power and due to organizing activities of voluntary units;
- 9. operational cooperation with the structures of the European Union, the NATO and other international organizations in the field of fire safety and protection of the population, humanitarian aid and civilian-military emergency planning.

#### **MAIN ACTIVITIES**

# Firefighting & Rescue ACTIVITY INCLUDES:

- defining the ways and means of carrying out the activity;
- keeping the personnel and the fire-fighting equipment in constant readiness for the implementation of the activity;
- Immediate dispatch of forces and means of fire notification;
- analysis and evaluation of the fire situation;
- attracting additional resources and resources;
- rescue or evacuation of people;
- containment and eradication of fires.







### MAIN ACTIVITIES (2)

## Rescue activity includes:

- limitation and liquidation of the accident.
- Immediate dispatch forces and means in disaster and emergency alert;
- analysis and evaluation of the accident;
- rescue or evacuation of people;
- rendering assistance to the injured;
- organizing the transport of the victims to the medical centers;
- mitigation of the accident.





### MAIN ACTIVITIES (3)

#### **State fire control:**

- Control of fire safety rules and norms in the design, construction and operation of the buildings, their reconstruction, renovation or change of using;
- control of the products using for building in the construction with the normative requirements for fire safety;
- o control over compliance with fire safety requirements.





### MAIN ACTIVITIES (4)

## Preventive activity includes:

- informing the public, including edition and spreading behavior, about dangers and risks of fires, disasters and emergencies;
- supporting the training and practical training of central and territorial executive authorities, response forces and the population;
- support for disaster-protection training in the pre-school and school education system and in the higher education system;
- assisting disaster planning.

# REGULATION FOR ORDER AND FUNCTIONING OF THE NATIONAL SYSTEM FOR EARLY WARNING AND ALERTING OF THE AUTHORITIES AND POPULATION IN CASE OF DISASTER AND AERIAL DANGER

1. System for early warning and alert of the executive power bodies;

2. System for early warning and alert of the population.



Capacity of the system is up to 28 000 officials. For every person up to 4 phone numbers can be input.

#### **National Disaster Protection Plan**

The Council of Ministers carries out the general management of disaster protection. A Disaster Risk Reduction Council has been set up to support this work.

The Council for Disaster Risk Reduction includes representatives of the ministries, institutions, the Bulgarian Academy of Sciences, Higher education institutions, Research institutes, The National Association of Municipalities in the Republic of Bulgaria, the Bulgarian Red Cross and legal entities, including non-profit legal entities, related to the reduction of the risk of disasters.

The Council shall develop and propose to the Council of Ministers a National Disaster Protection Plan.

# **Compulsory parts** of the National Disaster Protection Plan are:

- -Earthquake;
- Flood;
- Nuclear or radiation accident.

**The coordination** of the Union Rescue System is carried out through the Operational Centers of DGFSCP.


