GOALS



- 3. The parties will cooperate for improving the conditions, regulating the exchange of culture activities, services and products. We declare our will for coordination and partnership for sustainable development of existing and new festivals and events on the base of the traditions and the existing modern potential.
- 4. The parties will strive to make easier the contacts between different stakeholders, culture figures, artists, event managers, tourists, tour-operators etc. by use and popularize the elaborated platform http://strandja-fest.info/
- 5. The parties will cooperate in the fields of promotion of the festivals, culture events, customs, traditions in Strandja and preservation of culture identity of Strandja region
- 6. The parties will joint their efforts for education of the youth in acquaintance and respect of the culture and traditions of the different nations, in taking part in exchange of people, ideas, and will encourage organization of common youth events and festivals.
- 7. The parties will encourage their joint participation in the organization and implementation of activities envisaged in 3 years festive programme 2017-2020 for development of Strandja as a festive destination and promotion plan.
- 8. The parties will cooperate in the frames of different initiatives and activities for formulation of joint projects. The parties will take in mind that the financing of different future initiatives in the frames of joint projects will be defined and coordinated between them through additional consultations and agreements.
- 9. The parties will explain and promote the work of the newtork to other stakeholdres in the region, and in all over the world and they will work to integrate new members.



COORDINATIN AND GOVERNANCE OF STRANDJA FEST NETWORK

The Network will be led by a management/coordination voluntary-based committee consists of organizations or physical persons in order to ensure:

- Coordination of activities in order to facilitate implementation of 3 years festive programme 2017-2020 for development of Strandja as a festive destination and Joint Promotion Plan;

- To support maintaince and development of the Joint Festival Calendar created on the e-platform http://strandja-fest.info;
- To support maintaince and development of the e-promotional tools in social media: Facebook, Twitter, Google+;
- To coordinate implementation of joint promotional plan and activities for development of a common promotion, branding and marketing of Strandja as a festive destination;
- Jointly explore opportunities for funding, partnerships, and cooperation with other organization in Strandja region and beyond and in development of future joint projects.
